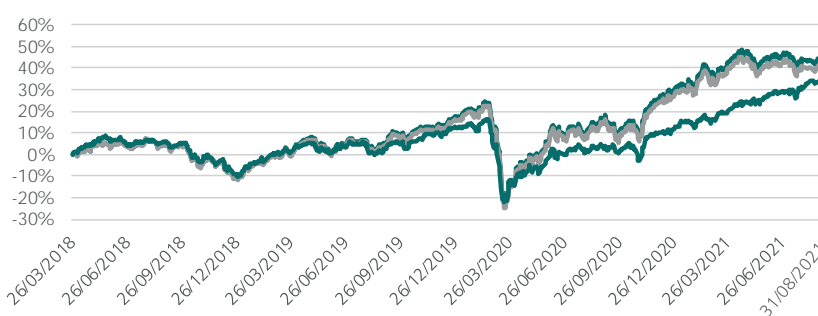

Richard also co-manages the TM CRUX European Fund.
