

The CRUX Asia ex-Japan fund underperformed the MSCI Asia ex-Japan index this month. The main positive contributors to fund performance were Consumer Discretionary, Financials, and Communication Services sectors. Chinese new energy auto manufacturer Li Auto, Taiwanese IC substrate manufacturer Unimicron, and Indian financial IndusInd Bank were our top contributors. The main negative contributors came from the Materials, Consumer Staples and Healthcare sectors. Indonesian miner Merdeka Copper, Chinese on-demand delivery company Dada Nexus and Chinese financial technology company Lufax were the main detractors to performance this month. Over the month, we reduced our exposure to the energy and materials sectors, and increased our weighting in industrial and technology hardware names.
