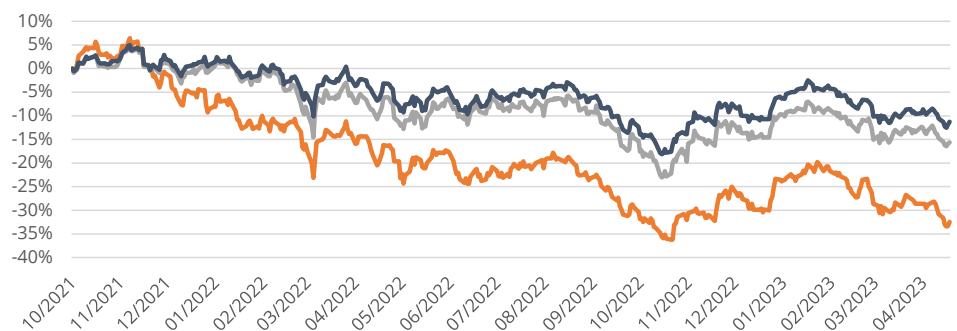

The main positive contributors to fund performance were Information Technology, Materials and Real Estate sectors with Korean entertainment company Hybe, copper mining company MMG and Indian engineering and IT services provider Cyient our top contributors. We also benefitted from being underweight in the large internet benchmark names Tencent and Alibaba. The main negative contributors came from the Consumer Discretionary, Consumer Staples and Healthcare sectors. Over the month, we reduced our exposure to the energy and consumer discretionary sectors, and increased our weighting in industrial names.
